Vizzi earned her Lonato first place medal after beating Simonton in the gold medal match. Vizzi's victory brings her 2023 World Cup medal count to three. She earned silver medals in Mixed Team Skeet and Women's Skeet team at the ISSF Rabat Shotgun World Cup in January.

"It's amazing just to be out there with the best in the world and on such a big field here in Italy," the Odessa, Florida, native said after securing the gold medal. "To come out on top is such a great experience and I am very blessed."
